



Dear Parents of Seniors,

Bruriah policy permits our seniors to have certain privileges that are not available to underclassmen.

One of these special privileges is the right to leave the school building during free periods. However, being able to go anywhere by car during school hours requires special parental permission.



We therefore request that all senior parents submit a signed form giving permission for their daughter to drive a car, carry passengers, and/or ride as a passenger in another's car, **during free periods.**

Frequent lateness in arriving to school in the morning may result in a 30 school day suspension of privileges.

Students who leave the building and abuse this privilege by not returning on time to class **may have the privilege revoked.**

Please sign the form below and return it before the first day of school. Any student found driving a car or riding in another student's car without **written parental permission** (ie. the form provided below properly signed) after the first day of school may risk suspension. These stringent measures are being taken to ensure "our" daughters' safety.

PLEASE NOTE: Due to the large number of staff members who drive to school, **STUDENTS ARE NOT ALLOWED TO PARK IN THE SCHOOL PARKING LOT.** Sufficient time must be allotted to find a parking spot each morning so students will not be late to class. Any student who parks in the school parking lot risks losing permission to drive to school.
